Dear Senator Murray:

King County was named in honor of Martin Luther King, Jr. to underscore the values of diversity, opportunity, and justice for all. I am proud to serve as Executive for one of the nation's largest and most diverse counties, which has been a home for immigrants over many years. King County currently has more than 360,000 foreign born residents with nearly 30 percent of Seattle's children born to immigrant families. Many of our thriving businesses are owned, managed, or employed by immigrants. Our schools represent an array of diverse cultures, and our region's economy thrives off the contributions from our immigrant communities.

The impact of a failed immigration system is felt throughout King County by immigrant families, service providers, businesses, county agencies, and other entities. King County has taken strong steps to locally address issues of immigration by creating policies that promote the inclusion of immigrants. We have also passed resolutions that call for comprehensive immigration reform. Most recently, I am proud that the County Council passed an ordinance promoting access to services for all King County residents by ensuring that county employees and county law enforcement provide service without reference to immigration status.

As King County Executive, I am committed to ensuring that immigrants are able to fully participate in our society, contributing their talents and skills toward a stronger county. I often hear stories of how immigrant families are affected by an imperfect immigration system; how businesses cannot hire high skilled service workers; how university graduates are unable to bring their talents to the workforce; and how tens of thousands of workers live in the shadows, unable to contribute to society in a way that would benefit all King County residents.


